Privacy Policy

1. Introduction

autoprofileexperts (“autoprofileexperts”) takes your privacy seriously. This Privacy Policy covers how autoprofileexperts collects, uses, discloses, retains, and protects your personal information. **If you object to anything in this Privacy Policy, or otherwise do not understand or agree to be**



bound by the terms of this Privacy Policy, do not use autoprofileexperts's Services. By using autoprofileexperts's Services, you agree to be bound by the terms of this Privacy Policy.

autoprofileexperts may change this Privacy Policy at any time without prior notice to you. You agree that autoprofileexperts may provide you with notice of such changes in any of the following ways: by requiring you to acknowledge and accept the revised version at your next login, via email from autoprofileexperts, and/or by posting a change notice on autoprofileexperts's Website for a reasonably limited time. **It is your responsibility to review any changes to this Privacy Policy. If you object to any of the changes to this Privacy Policy or otherwise do not understand or agree to any of the changes to this Privacy Policy, do not use autoprofileexperts's Services.** By continuing to access or use autoprofileexperts's Services following notice of any change to this Privacy Policy, you agree to and are

Any terms not specifically defined herein shall have the meanings set forth in the Terms of Use. For the purposes of this Privacy Policy, “autoprofileexperts” means and includes autoprofileexperts and its affiliates, subsidiaries, investors, owners, members, shareholders, officers, directors, employees, agents, representatives, and assigns.

2. Information Collection and Use

2.1. Generally

This Privacy Policy covers how autoprofileexperts collects, uses, discloses, retains, and protects your personal information. autoprofileexperts collects personal information from you and the devices (including mobile devices) you use to access autoprofileexperts’s Services. Categories of personal information that autoprofileexperts collects includes



without limitation: (a) identifying information such as your name, address, email address, and phone number; (b) transaction information; (c) financial information such as credit card or bank account numbers; (d) other information you provide to autoprofileexperts through your use of autoprofileexperts's Services; and (e) other information autoprofileexperts is required or authorized by applicable law to collect to identify you or verify other information collected. autoprofileexperts collects your personal information to (a) provide you with access to and use of autoprofileexperts's Services, (b) operate, improve, and personalize autoprofileexperts's Services, (c) contact you regarding your use of the Services, (d) provide you with customer service and support, (e) customize autoprofileexperts's advertising and marketing, and (f) to detect, prevent, and mitigate fraudulent or illegal activities.



2.2. Tracking Technologies and Cookies

As is true of most websites, autoprofileexperts automatically collects certain personal information from you and your devices (including mobile devices) and stores it in log files. Categories of personal information that autoprofileexperts collects in this manner include without limitation: (a) internet protocol (IP) addresses, (b) browser type, (c) internet service provider (ISP), (d) referring/exit pages, (e) operating system, (f) date/time stamp, and (g) clickstream data.

autoprofileexperts uses this personal information and technologies such as beacons, tags, and scripts to analyze trends, to administer autoprofileexperts's Services, to track your movements around the Website, and to gather demographic information about autoprofileexperts's member base as a whole. autoprofileexperts may place a text file called a "cookie" in the browser files of your computer. In addition, autoprofileexperts uses encrypted cookies to authenticate your identity on each page after you log on to the Website. You can refuse cookies by turning them off in your browser. If you have set your browser to warn you before accepting cookies, you will receive the warning message with each cookie. Some of autoprofileexperts's Services may not function properly if your cookies are disabled.

The use of cookies by third-parties is not covered by this Privacy Policy. autoprofileexperts does not have access or control over these third-party cookies. These third-parties



use session ID cookies to make it easier for you to navigate autoprofileexperts's Website.

Our third-party partners employ clear gifs (a.k.a. Web Beacons/Web Bugs), images, tags, and scripts that help them better manage content on autoprofileexperts's Website. autoprofileexperts ties the information gathered by these third-party partners to your personal information.

2.3. Google AdSense

autoprofileexperts may use Google AdSense to publish ads on the Website. When you view or click on an ad, a cookie will be set to help better provide advertisements that may be of interest to you on autoprofileexperts's Website and other websites. 2.4. Facebook Connect or Other OpenID Providers

3. Information Sharing and Disclosure

4. Data Storage and Retention

autoprofileexperts will retain your personal information as long as it is necessary and relevant to provide you with autoprofileexperts's Services.
